### **Panel Chair Summary**

The Northern Trust Adoption panel continues to make positive progress. As outlined within this report the number of panels convened has increased, this is as a result of two additional panels being convened to expedite the decision making process for 4 children. This has illustrated that Panel can meet as demand requires, affording flexibility and responsiveness to need.

In October 2021 a new panel Chair took up post, Mr Lee Wilson (Assistant Director of Social Work Governance, Workforce Development and Training). In addition to a new chair, the Trust has also provided the panel with two new professional advisors, Mrs Deirdre Keenan and Mrs Catrina Brown (Principal Practitioners – Corporate Parenting). The Trust Decision Maker is Mrs Julie Patterson (Assistant Director, Corporate Parenting).

The panel chair has enhanced the accountability of panels by establishing an adoption panel learning group. This group meets quarterly and is attended by Heads of Service from Corporate Parenting. The group considers areas of good practice and improvements that arise from monthly panel meetings. Matters that need to be escalated from this group are tabled at the Fostering and Adoption Governance and Improvement Group, chaired by the decision maker, Mrs Julie Patterson.

There has continued to be noted improvements in the quality of reports presented to panel throughout this reporting period. The full use of the CORAM BAAF, Adoption and Fostering Academy assessment reports has now been in practice for a year. The feedback from applicants has been overwhelmingly positive with prospective adopters describing in panel how the questions powerfully bring the role of becoming a carer to life.

The period April 2021- March 2022 has been a busy period for Adoption Panel; panel membership has a strong balance of skill and experience representing a diverse range of disciplines, service users by expert and independent representatives. The Panel displays a high degree of commitment and enthusiasm to the work, and applies an appropriate level of scrutiny to assessments with the focus always being on meeting the needs of children and safeguarding their welfare. The Panel further recognises the responsibility it has in balancing this with a need to ensure that applicants feel welcome and respected by the Adoption Panel, during population lockdowns the panel moved to a virtual platform, however consideration is now being given to a hybrid approach that will facilitate a face to face meeting for all prospective adoptive carers.

The Adoption Panel will continue to evolve to accommodate changes in policy, procedure, guidance and legislation. To support panel members they will be provided with training and development opportunities, plus panel specific training.

The Adoption Panel Learning Group provides the opportunity to direct feedback on the quality of reports presented, to highlight any issues, concerns, themes and acknowledgments of outstanding practice, which are addressed via the panel chair and trust decision maker.

Matters that have been routinely addressed during the reporting period are, the quality of reports to panel, as well as the robustness of adoption support plans including contact plans; this is in line

with the Trust guidelines that require us to address future support needs of adoptive children in particular.

The quality of reports presented to Adoption panel continues to be strengthened along with the quality assurance role of Team Leaders and Social Work Service managers, prior to the reports being submitted to panel. The Panel's Professional Advisor of which there is now two, previously one, provides panels with the consistent quality assurance and advice that panels require in order to make recommendations. The Panel Chair and panel members all reported significant improvements in the quality of reports being presented to the adoption panel.

The Panel Chair (Mr Lee Wilson) is required to produce an annual performance report. The analysis laid out within this report provides the following assurance.

- Adoption reports are of an increasingly good standard including some that are outstanding
- Trust Decision Maker timescales are being met
- The Trust continues to provide child centred adoption services to children and carers
- There is a good summary and analysis for matching children with adopters
- There are continued improvements in timescales for adoption assessments
- Professional Advisors continue to guide the panel with consistent advice and quality assurance
- A learning group has been established with Heads of Service to address needs and share good practice identified by panel members. This group meets quarterly and the panel chair and professional advisors are invited to this meeting, this is a useful group to drive continued improvements in panel business.

Areas for further development

- Consideration will be given to membership and representation of a young person with care experience sitting on some panels
- Develop further strategies to keep a focus on the child when considering all reports presented to panel
- Move to a hybrid virtual / face to face meeting to facilitate more meaningful engagement with prospective adoptive carers
- Rotation of membership to build experience for Social Work Service Managers and Senior Social Work Practitioners

Overall, the Trust's arrangements for Adoption panel continues to work well and the Corporate Parenting Service is working towards ensuring continuous improvements to the panel and the processes of panel. The following is statistical information detailing the activity of the panel, according to the types of cases that have been presented.








# Age Ranges of Children Adopted In The Timeframe

## Length of Time Elapsed Between Freeing Order and Adoption Order Granted For All Children Adopted In the Timeframe



Total 1 child


### Children Adopted In The Timeframe Who Were Eligible For Adoption Allowance

From 11 children adopted – 2 children were recommended for adoption allowance.




### Children Who Had BI Decisions Recommended In This Time Frame & Age At Time Of BI
