

Managing people on caseload on 31st March 2022

Summary

Point in Time Orders – Table 1

On 31st March 2022, PBNI were managing 3,947 service users on a combined total of 4,970 orders, licences and sentences. 707 of which were new onto caseload.

There is an increasing upward trend in orders and licenses since the start of the reporting period, increasing by 12% since March 21: although there is variation in the change in the individual types of orders, licences and sentences.

Probation orders continued to be the most common, accounting for 36% of all orders. Probation orders increased by 22% and Determinate Custodial Sentences (DCS) increased by 20% since December 2020.

Custody Probation orders saw an increase of 55% with 65, compared to 42 in March last year.

Community Service orders continued to decline, with numbers 9% lower than the same date the previous year. March 2022 CSOs are now 24% less than Dec 2020. They now account for 8% of orders.

On 31st March 2022, 14% of orders were allocated to prison based teams preparing for the prisoner release into community supervision, with 86% of orders being managed in the community.

The number of sex offender licences has reduced by 11% since Dec 2020.

4% of orders are Enhanced Combination Orders (ECO).

Demographics of people on caseload – Table 2

The breakdown of caseload by gender has remained consistent in March 2022 compared with previous years, with males making up 88% of people on caseload and females accounting for 12%.

The most common age range of people on an order was 30 to 39 year olds, with 34% of males and 33% of females belonging to this demographic.

The most common offence category for females was Offences against the State, which accounted for 24.5% (187) of female offences on 31st March 2022, followed by 16% (119) Dishonesty Offences.

For males, the most common offence category was Offences against the Person, which accounted for 18% (1112) of male offences, followed by Drug Offences and Immigrations Offences 15% (898)

Characteristics of people on caseload – Tables 3 and 4


100% of caseload had an ACE assessment in March 2022, 28% of which were classed as High ACE. The majority of ACES fell in the medium band, which accounted for 43%.

PPANI levels remained consistent, with PPANI cases continuing to make up 13% of caseload.

There was a slight increase in the proportion of Cat 1 PPANI which increased to 71% of PPANIs, from 68% in March 2021. Cat 3 remains the smallest category, accounting for 4% of PPANIs.

SROSH levels also remained consistent at 3.6% of total caseload. The proportion of SROSH cases in prison increased slightly to 84%, from 79% the previous year.

Point in Time trends taken on the last day in March 2019 to 2022








Count and Percentage of Males and Females 31st March 2019, 2020, 2021, 2022






Trends in people by directorate






People by directorate (Prison, Specialist and Other)




Offences By Gender

Males on 31st March 2022


Females on 31st March 2022





Characteristics of People in the Year






Methodology

Each month, PBNI statisticians take a download of the data from the caseload management system on the last working day of the month. Referred to as point in time, it is a snapshot taken at a point in time to reflect the management of service users and their orders or licences.

The reports produced from the quality assured data, issued at the end of each financial quarter and year for data at a point in time at the end of June, September, December and March. Each report is similar in style and layout, with each content applicable to the quarter or year together with trends from previous time-periods.


All statistics shown before this methodology page are point in time.


PBNI supervise individuals issued with Court orders mandating statutory supervision. PBNI also supervise people subject to post-custody supervision upon release, and those issued life or indeterminate custodial sentences where the period of supervision is longer and in some cases for life.

People leave caseload by completing their order (successfully), order is revoked or breached. There are a small number of people who have had a complete discharge and their counts will be included in the number who have completed their order/sentence.

The total number of people is obtained by combining those who came onto caseload, continued from the previous year, and also those who finished their order in the year.

Supervision Stages – Table 5

New People on caseload

2455 new people came onto caseload in 21/22, an increase of 8% from 20/21.

16% of the new people onto caseload had been released from prison. There is no data available for actual date of release (ADR) in 20/21, so we are unable to compare this to previous year.

People completing in 21/22

37% of caseload completed their order in 21/22, 2248 people. Of those who completed their order, 82% did so successfully, with 18% finishing on a breach or recall. This shows a reduction on the previous year's success rate of 84%.

21/22 saw 60% of orders continuing from the previous year.

Victims

The number of new registered victims has increased each year, which continued in 21/22 with 280 new victims registered, up by 8% from 20/21.


Of the 496 victims registered at the end of 21/22, 69% are female.

Reports Completed in the year

Magistrate's court reports account for the majority of reports completed in the year (3706).

The total of reports completed in 21/22 (7049) has increased by 67% on the previous year, with the greatest increase being seen in pre-sentence reports - up 282% from 20/21.

Trends in reports completed


