## 1. About the Pharmaceutical Society NI

The Pharmaceutical Society NI regulates pharmacists and registered pharmacies in Northern Ireland. Our primary objectives are to protect the public and patients, uphold professional standards and maintain public confidence in the pharmacy profession.

# 2. Purpose of the Code

The Pharmacy (Northern Ireland) Order 1976 imposes an obligation on the Council of the Pharmaceutical Society of Northern Ireland to "set standards relating to the conduct, ethics and performance expected of registered persons".

The Pharmaceutical Society NI Code (Professional standards of conduct, ethics, and performance for pharmacists in Northern Ireland) (the Code) is used to guide and support pharmacists in their scope of practice, professional development and decision making. It underpins all other professional standards and guidance documents we issue. The Code also informs the public and patients on the professional conduct and behaviours they can expect from their pharmacist. It puts patients' interests first and reinforces the concept of patient-centred professionalism and care.

The Code is regarded as governing the conduct of all pharmacists both within and outside the practice of pharmacy. Breaches of the Code could form the basis of a complaint of misconduct and an appearance before the Statutory Committee of the Pharmaceutical Society NI. The Statutory Committee can determine to remove the registration of a pharmacist or apply another appropriate sanction.

# 3. Why we are consulting

It is important we review the Code on a regular basis to ensure it is fit for purpose. Since the current Code<sup>1</sup> was last reviewed in 2016 there have been

many changes and developments within the pharmacy sector, including increased independent prescribing, greater clinical interaction with patients, new technologies and changes in healthcare demands, which have impacted the pharmacy profession.

In the new draft Code, we have taken a different approach in which pharmacists give an affirmation to provide safe, effective, and compassionate care by abiding by seven Standards. For each of the seven Standards we have listed behaviours which pharmacists must demonstrate to meet the Standards.

Much of the content of the Code is unchanged as the fundamental principles of patient care remains as relevant today as in the past. However, the emphasis and language used in the Code has changed. We have tried to make the Code more accessible and relevant to both the profession and the public and to allow for broad standards which can be applied in all situations now and in the future life of the Code.

Following input from our initial public call for evidence from October 2022 to January 2023 and discussions with stakeholders and the Code Advisory group, we have added new sections, for example, on professional judgement, accountability and patient rights. New required behaviours have been added to address the developing role of pharmacists

Following discussions with stakeholders the new draft Code was developed for pharmacists exclusively.

### 4. The consultation process

To date, the consultation process has involved an initial public call for evidence followed by engagement with key stakeholders and in-depth sessions with an expert Code Advisory Group representing patients and the pharmacy profession. We would now like to consult more widely with the pharmacy

profession, interested parties, patients and the public to ascertain their views on the proposed new Code.

# 5. How can I respond to this consultation?

The consultation will run for 8 weeks from 23 October until 18 December 2023. During this time, we would welcome feedback from individuals and organisations. We have published the consultation documents on our website:

- 5. Is there any supplementary guidance or information you would require to help your understanding of the information contained in the Code?
- 6. How would you suggest we can make the Code better known and understood by pharmacy trainees, pharmacists, patients and the public?
- 7. Do any aspects of the draft Code have equality implications for groups or individuals based on one or more of the equality categories?
