

Key trends



In the w/e 17/05/20 the average R3 heifer price in the EU was 353.4c/kg, an increase of 1.2c/kg from 352.3c/kg in the w/e 19/04/20.





GB moved down to sixth position on the league table with an equivalent R3 heifer price of 380.7c/kg, a 5.8c/kg increase from the 374.8c/kg paid in the w/e 19/04/20. The differential between GB and the EU average widened from 22.5c/kg to 27.3c/kg in the w/e 17/05/20.



In ROI the R3 heifer price was 358.6c/kg in the w/e 17/05/20, an increase of 12.0c/kg from the w/e 19/04/20. This placed it in eighth position in the league table, 5.2c/kg above the EU average price and 25.2c/kg lower than the same price in NI.

The euro increased to €1=88.2p in the w/e 17/05/20.
