NOTICE UNDER ARTICLE 8(4) OF THE GAS (NORTHERN IRELAND) ORDER 1996

In exercise of its powers under Article 8(4) of The Gas (Northern Ireland) Order 1996 (“the Order”) the Northern Ireland Authority for Utility Regulation (“the Authority”), hereby gives notice as follows:

- 1) It proposes, in accordance with Article 8(1) (c) of the Order, to grant a licence to supply gas to EP Commodities, a.s. (EP Commodities) a statutory corporation, established in the Czech Republic and having its principal place of business at Klimentaska 46, 1100 Praha, Czech Republic (the “Proposed Licensee”).
- 2) The Authority considers that the grant of the proposed licence would be an appropriate course of action for it to take as such grant is in keeping with the Authority’s principal statutory objective in that it promotes the development and maintenance of an efficient, economic and co-ordinated gas industry in Northern Ireland.
- 3) The Authority further considers that the application made by the Proposed Licensee has been made in the prescribed manner and confirms that the appropriate fee has been submitted.
- 4) The purpose of this notice is to bring to the attention of persons likely to be affected by the grant of the proposed licence referred to above, and to invite representations or objections in connection thereto. Any representations or objections with respect to the proposed licence may be made on or before 25 August 2023 to:
