#### 3 CONFIDENTIALITY OF CONSULTATIONS

The Freedom of Information Act 2000 gives the public a right of access to any information held by a public authority, namely the Department in this case. This includes information provided in response to a consultation. The Department cannot automatically consider information supplied to it in response to a consultation to be confidential.

However, it does have a responsibility to decide whether any information provided by you in response to a consultation, including information about your identity, should be made public or be treated as confidential. If you do not wish information about your identity to be made public please include an explanation in your response. However, please be aware that confidentiality cannot be guaranteed, except in very particular circumstances.

#### 4 REVIEW OF BATHING WATERS

#### 4.1 Introduction

The referendum on 23 June 2016 resulted in a decision that the UK should leave the European Union. However, until such time as exit negotiations are concluded, the UK remains a full Member of the European Union, and all the rights and obligations associated with EU membership remain in place. EU legislation will continue to be negotiated, implemented and applied during this period. It is the outcome of those exit negotiations that will determine the arrangements that should apply in relation to legislation in the future once the UK has left the European Union.

The purpose of the Bathing Water Directive (2006/7/EC) is to preserve, protect and improve the quality of the environment and to protect human health.

The Directive lays down provisions for the monitoring, classification and management of bathing water quality; and for the provision of information to the public.

It applies where the Department of Agriculture, Environment and Rural Affairs ("the Department"), as the competent authority in Northern Ireland, expects a large number of people to bathe, and where bathing is not permanently prohibited or where permanent advice against bathing has not been issued.

It does not apply to swimming pools and spa pools; confined waters subject to treatment or used for therapeutic purposes; or to artificially created confined waters separated from surface water and groundwater.

The Bathing Water Directive was transposed in Northern Ireland through The Quality of Bathing Water Regulations (Northern Ireland) 2008 (as amended), which lists the 23 currently identified bathing waters in Northern Ireland.

The Department's "Review of and Consultation on the Identification of Bathing Waters in Northern Ireland" in 2011 gave a commitment to undertake the next review of bathing waters in 2017 and to subsequent reviews taking place every 6 years thereafter.

#### 4.2 Identified Bathing Waters

The Department decided not to review the status of the 23 currently identified bathing waters in Northern Ireland on this occasion.

These bathing waters are well-established, have recognised bathing water operators in place at each site, and do not have permanent prohibitions in place or permanent advice issued against bathing. The only reason for de-identifying any of those bathing waters would have been on the grounds of lack of usage.

Therefore, the Department decided that undertaking usage surveys at each of those 23 sites - which are clearly important recreational and tourism assets for Northern

Ireland - would have been neither an effective use of the Department's resources at this time nor in the wider interest.

#### 4.3 Nominated Bathing Waters

Notwithstanding this, a review also provided the Department with an opportunity to invite nominations for other sites that could be taken forward as candidates for identification as bathing waters.

The Department, therefore, wrote to the Chief Executives of councils and to key stakeholders on 29 February 2016 inviting nominations for any additional coastal or inland waters which could meet the following criteria:

- bathing is not prohibited or inadvisable for reasons of safety;
- usage at the site exceeds a guide value of 45 bathers on at least one occasion or 100 beach users on at least two occasions within a maximum of 8 survey dates during the bathing season (1 June 15 September 2016);
   and
- there is an appropriate body willing to take on the formal responsibility of bathing water operator.

In response to this invitation, Ards and North Down Borough Council nominated Cloughey; and Newry, Mourne and Down District Council nominated Kilclief, Ballyhornan and Killough.

The Department subsequently conducted usage surveys at each of those sites over the course of the 2016 bathing season. Despite it being a relatively mixed summer, the Department selected some of the better days in terms of the weather conditions and temperatures, so as to reflect the greatest numbers using those sites.

In addition, usage surveys were undertaken both on weekdays and weekends - with one completed on a public holiday and another on a bank holiday weekend - so as to cover a broad range of days and times.

A total of 7 usage surveys were completed at each of the nominated sites. The results can be found at annex A. These show that:

- Cloughey exceeded the guide value of 45 bathers on one occasion and 100 beach users on one occasion (both on 19 July 2016);
- Kilclief exceeded the guide value of 45 bathers on one occasion (19 July 2016) and 100 beach users on three occasions (17, 19 July and 15 August);
- Ballyhornan exceeded the guide value of 45 bathers on one occasion (19
   July 2016); and
- Killough did not exceed the guide value of 45 bathers or 100 beach users on any occasion.

While not a purpose of this review, it is worth observing that the relatively limited, formal car-parking facilities at Kilclief and Ballyhornan are likely to be a constraint on the numbers visiting those locations.

#### 4.4 Proposal

The Department proposes that Cloughey, Kilclief and Ballyhornan should be taken forward as candidate sites for identification as bathing waters in Northern Ireland; and that Killough should not be taken forward as a candidate site for identification as a bathing water in Northern Ireland.

This proposal is subject to the Department being satisfied that bathing is not prohibited or inadvisable for reasons of safety; and that there is an appropriate body willing to take on the formal responsibility of bathing water operator.

#### 4.5 Next Steps

The Department, subject to any responses received to this consultation paper and the Minister's approval, would amend Schedule 1 to The Quality of Bathing Water Regulations (Northern Ireland) 2008 (as amended) so as to include any successful candidate sites in the list of identified bathing waters.

The intention would be to have those identifications in place for the start of the 2017 bathing season.

The Department welcomes your comments on this review of bathing waters in Northern Ireland.

A synopsis and analysis of the comments received will be published.

#### 5 MANDATORY CONSULTATION ARRANGEMENTS

#### 5.1 Equality Impact Assessment

The Department has completed a preliminary screening exercise on the proposal contained in this consultation paper. There is no evidence that there would be any impact on issues related to equality. Therefore, the Department does not consider it necessary to undertake a full Equality Impact Assessment.

#### 5.2 Human Rights Act 1998

The Human Rights Act 1998 implements the European Convention on Human Rights. The Act makes it unlawful for any public authority to act in a way that is incompatible with those rights.

The Department considers that the proposals contained in this consultation paper are compatible with the Human Rights Act 1998.

#### 5.3 Rural Proofing

Rural proofing is a process to ensure that all relevant Executive policies are examined carefully and objectively. It determines whether or not those policies have a different impact in rural areas from that elsewhere, given the particular characteristics of rural areas.

Consideration should be given to the policy adjustments that could be made to reflect rural needs so that, as far as possible, public services are accessible on a fair basis to the rural community.

The proposal that Cloughey, Kilclief and Ballyhornan should be taken forward as candidate sites for identification as bathing waters can be seen as making a positive contribution to the rural communities in those locations. Formal identification should increase the profile of those areas, improve the potential for tourism and provide for increased spend in the local economy.

#### 5.4 Initial Regulatory Impact Assessment

The policy objective behind the review is straightforward. It is "to preserve, protect and improve the quality of the environment and to protect human health by complementing the Bathing Water Directive". This 2017 Review of Bathing Waters in Northern Ireland does not go beyond the minimum requirements of the Bathing Water Directive.

This means identifying locations where the competent authority (the Department of Agriculture, Environment and Rural Affairs) expects a large number of people to bathe, and where there is no permanent bathing prohibition or no permanent advice against bathing has been issued.

There are already 23 identified bathing waters in NI. The consultation paper explains the Department's decision not to review each of those sites on this occasion. Consequently, there are no additional costs or benefits associated with those identified bathing waters, and for that reason they are not the subject of this initial Regulatory Impact Assessment.

The Department did, however, receive nominations from Ards and North Down Borough Council for Cloughey; and from Newry, Mourne and Down District Council for Kilclief, Ballyhornan and Killough for potential identification as bathing waters.

The consultation paper proposes that Cloughey, Kilclief and Ballyhornan should be taken forward as candidate sites for identification as bathing waters, based on having met the Department's criteria (see page 6). Therefore, this initial Regulatory Impact Assessment concentrates on those three locations.

#### Costs

Should the three locations be identified as bathing waters, the Department would incur additional water quality monitoring costs of approximately £15,000 - £20,000 per annum.

There would also be some costs associated with a review of any discharge consents at those locations, and with assessing compliance once they have been added to the sampling schedule. However, these costs are expected to be minimal.

In addition, the bathing water operator at each of those sites – which in this case should be Ards and North Down Borough Council for Cloughey; and Newry, Mourne and Down District Council for Kilclief and Ballyhornan – would be expected to provide the necessary signage on which to present information to the public. This has been estimated previously at approximately £2,000 per sign, with ongoing maintenance costs.

There is the potential for Northern Ireland Water to incur additional costs, should it be required to provide improved waste water treatment in the relevant catchments. This would be necessary to comply with the stringent bathing water quality standards required by the Bathing Water Directive.

The Bathing Water Directive does provide for the application of an "infeasible or disproportionately expensive" argument, but only when a site is an identified bathing water and a "sufficient" classification is considered unachievable. In those circumstances, the Department would issue permanent advice against bathing at that site.

The Department, therefore, expects any potential costs to Northern Ireland Water to become clearer once any identifications of bathing waters have been made; and in the course of the Department making an assessment of those bathing waters.

Should a decision be taken to identify any of those sites as bathing waters, it would be necessary to amend The Quality of Bathing Water Regulations (Northern Ireland) 2008 (as amended) to add the site(s) to the list of identified bathing waters. Any comments received to this initial Regulatory Impact Assessment would inform a final Regulatory Impact Assessment that should accompany those amending Regulations.

#### **Benefits**

The principal benefits, should the sites be identified as bathing waters, mirror those of the policy objectives – that is, preservation and protection of the environment and an improvement in its quality; and the protection of public health.

This would be achieved through the placing of general duties on the Department, such as establishing bathing water profiles; monitoring of bathing waters and

provision of information to the public; and the assessment, classification and management of bathing waters.

The raised profile of those areas following any identification as bathing waters should also improve the potential for tourism and provide for increased spend in the local economy.
