CHIEF EXECUTIVE'S DIARY



Welcome to this edition of Probation News. It has been another busy few months with plenty of opportunity to engage with staff and key partners. With Domestic Abuse being a priority identified for Probation from our consultation on the Corporate Plan, I was delighted to welcome Sarah Mason, Chief Executive. Women's Aid Federation NI and some of her staff to our office to mark the 16 Days of Action campaign. The meeting was very productive, and we had a good discussion on how we can enhance our partnership working to tackle Domestic Abuse. Unfortunately, the number of victims of this heinous crime continues to increase as latest PSNI figures show that 20% of their caseload relates to Domestic Abuse incidents. We have also seen an increase in the number of cases we are dealing with. In 2021 there were 30 cases related to Domestic Abuse that registered with the Probation Victims Unit and in 2022 this had increased to 83 cases.

To further enhance our partnership working in this area, I was privileged to take part in a panel discussion as part of a recent conference organised by the Bar Library focussing on the Domestic Abuse and Civil Proceedings Act (NI) which became law last year. It was an excellent event and provided an opportunity to highlight the work we are doing in this area.

Probation's caseload has increased and staff are working with people whose needs are becoming increasingly complex which includes serious mental health and addiction issues. Many have experienced multiple adverse childhood experiences and suffer from intergenerational trauma.

Probation is well positioned within the justice sector to lead an approach to trauma-informed practice, and we have given a particular focus to further developing this area of work within our new Corporate Plan. We are organising a staff development day at the end of March on 'Supporting our People to Provide a Trauma Informed Service' and I am looking forward to the discussion and hearing your ideas for further developing this within Probation.

It is important to keep up to date with what is happening within Probation in other jurisdictions and I was very pleased to attend the Five Nations of Probation meeting. I also attended with staff from PBNI the Public Protection Advisory Group Annual Seminar in Dublin and it was a good opportunity to engage with colleagues in Probation, Prisons and Policing in both jurisdictions and learn from each other.

The Directors, Head of Communications and I have also continued briefings with political party groups which has provided an opportunity to discuss key issues for PBNI, seek views to inform our Corporate Plan and to raise issues which we would wish to put to a new Minister and Executive.

I was also delighted to welcome the Right Hon. Lord Mayor of Belfast, Christina Black to our offices at the start of the year. During her visit she met with Probation staff and visited our Graffiti Removal Service which works in partnership with Belfast City Council to clear away unsightly graffiti in the area. It was great to see a social media post from a local Councillor calling for additional funding for Probation for this work!

To coincide with this year's European Victims Day of Crime we also recently welcomed Geraldine Hanna, Victims of Crime Commissioner Designate for a seminar to discuss partnership working to improve victim services. This is the first in a series of themed engagements we plan to hold with a range of our partners during the year.

Internally, I have been working with the senior team to take forward organisational change and as part of this review a new senior leadership structure is now in place. I would also like to take the opportunity to formally welcome Melissa Spence and Emer Loughran as Assistant Directors and Michael McCracken as Head of Psychology and Programmes. We will continue to build an organisation that is fair and inclusive where everyone feels able to put forward their views and feels valued for their contribution. We are also continuing to make progress working with the Department of Justice to take forward a programme of pay modernisation.

Our Corporate Plan 2023-26 is now in the final stages of development, and I would like to thank our staff, Board members, partners and other organisations who took the time to participate in the consultation. These views have informed our strategic priorities over next three years and key areas of work.

There are of course many challenges ahead, but I believe that the new Corporate Plan will provide the basis for us to develop our people and services and with confidence to ensure we continue in our aim of changing lives for safer communities.



CHAIR'S INTRODUCTION



The Board have in the past year developed the Corporate Plan 2023-26 which will be presented to the Department of Justice shortly. Of course, in the absence of a working Executive and Assembly at Stormont we also do not have a Justice Minister as yet to approve the Corporate Plan or indeed allocate a budget for 2023-24. It's not unreasonable to presume that there are uncertain times ahead, indeed that would be an understatement. I am all too aware of the challenges uncertainty brings, particularly to staff and service users, and with an ongoing cost of living crisis at this current time.

I am delighted with the Corporate Plan drafted following extensive internal and external engagement over the past 6 months to consult on its contents. Partnership working is a key part of our Plan, and we invited our Justice, Community and Voluntary sector partners, as well as staff and service users to help shape the future of probation services in Northern Ireland. We held consultations in person across the regions and invited submissions remotely and online.

The pace of recovery from the pandemic and clearing back logs within the Justice system, is highly likely to increase demand for probation services and how this is being planned for, managed and resourced is an important element of this Corporate Plan 2023-26. Likewise, the response to the pandemic also identified innovative and new ways of working to deliver services and these are embedded in this Plan.

The consultation took place during a period of political, economic and operational uncertainty. Like all public services, Probation is likely to face reductions in its budget over the coming three-year period. Any reduction in budget is likely to impact upon our service delivery and it is imperative we try to mitigate the impact of budget cuts on our front-line delivery as much as is feasibly possible.

Probation's caseload has increased, and staff are working with people whose needs are becoming increasingly complex. Many of those who are supervised by Probation are suffering from poor mental health, addictions and some have experienced multiple childhood adversities and suffer from intergenerational trauma. Our operational staff have been trained to deliver trauma-informed practice and delivering this holistic approach on an individual basis takes significant time and effort. Some of those challenges will be discussed at the planned conference on 28th March.

There remain a number of significant workforce issues which will continue to be relevant over the coming Corporate Planning period.

In particular, there is a need to progress the business case for changes to pay structures to enable us to retain and attract social work staff. The Board is conscious of the pressures on staff managing increased caseloads and the potential impact of deviating from standards that reduces the level of engagement with service users.

From the Board's perspective, we want to present a plan that reflects our desire to continue to be an organisation which is innovative, creative, collaborative and solution focused. Working alongside our partners we want to implement learning from the last three years and improve our services to provide a high quality, professional service to all.

On a sad note, I attended the funeral of our colleague Geraldine Braniff in February. Geraldine had worked in Probation for 44 years. It was an extremely moving service and one could not help but feel for the family. At our Board meeting we held a minute's silence and on behalf of the Board I would extend the Board's condolences to husband Sean and the wider family circle.

Finally, I want to congratulate the Chief Executive Amanda Stewart on being awarded the OBE by His Majesty King Charles recently at Windsor Castle. This is a significant Honour for Amanda and well deserved.








PROBATION'S SENIOR LEADERSHIP TEAM

PUBLIC PROTECTION ADVISORY GROUP HOLD SEMINAR AND PUBLISH IRISH PROBATION JOURNAL

The 13th Annual Public Protection Advisory Group Seminar, jointly chaired by the Chief Executive of the Probation Board for Northern Ireland and the Director of the Irish Probation Service, was held in the Probation Service headquarters in Smithfield, Dublin.

The theme of the seminar this year was "Delivering quality front line services to make communities safer" and consisted of presentations by each of the PPAG member organisations and featured a mix of subject approaches on a range of topics. The presentations whilst diverse had the common thread of the overall seminar theme of front-line service delivery to pull them together. Detective Superintendent Derek Maguire from An Garda Siochana provided a fascinating insight into the investigations into human trafficking while Hollie Murray,

Senior Officer NI Prison Service spoke about the rehabilitative education and vocational programmes in Hydebank Wood. PPANI Co-Ordinator Julie Smyth described Public Protection Serious Case Reviews in Northern Ireland while Dr Sarah Jane Winders from the Irish Prison Service took a psychological approach as she delivered an evaluation of the 'Building Identity' Programme. Finishing off the day was Tracey Carroll, Probation Service Probation Officer who spoke about a complex individual case to detail the work involved and its impact and Probation Board's Emer Loughran who gave a fascinating view into how Probation works in and responds to the complex community of North Belfast.

Probation Chief Executive Amanda Stewart said: "One of the most critical elements of our role is working with those who have committed sexual and violent crime. We carry out this role in partnership with the Police Service of Northern Ireland, Northern Ireland Prison Service and others in order to reduce the number of victims of crime."

Probation works all year round to tackle Domestic and Sexual Violence through support for victims of domestic abuse who have registered with our Victim Information Scheme and through challenging and holding to account perpetrators of Domestic and Sexual Violence through our **Programmes and Interventions.**

PROBATION HIGHLIGHTS WORKING WITH VICTIMS OF CRIME

Probation recently marked European Victims of Crime Day with a social media campaign and an internal campaign which included introducing Probation's Victim Champion, Director of Operations Gillian Montgomery.

Gillian's role as Victim Champion is to promote the importance victims in Probation's day-to-day work and ensure their needs are considered at every stage of the Criminal Justice process, including strategic level, policy, corporate and operational. It is important to Probation the service that victims of crime can expect from Probation are enhanced and they receive the quality of support they deserve.

Gillian said: "My role as Victim Champion is to ensure the needs of victims of crime are considered throughout Probation. Our staff - whether they are working in courts, in the community or in custody - places the victim at the centre of their work.

Work that not only includes challenging criminal behaviour but also addresses the impact of crime on the victim.

Our Victim Information Unit plays an important role in keeping registered victims informed about the justice process, while providing them support to begin to address the trauma they have been through. We will continue to take every opportunity to ensure the needs of victims of crime are addressed as we work in partnership to change lives for safer communities."

The purpose of the Victim Information Scheme is to give victims information about the Criminal Justice System and key stages of the sentence of the person who has offended in a manner which is accessible, understandable and supportive.

Probation's Victim Information Scheme provides information to registered victims about what it means when someone is sentenced to a Court Order which requires supervision by Probation. A member of staff based in the PBNI Victim Information Unit will explain what the Court Order means and what the individual who has been sentenced must do as a result of the order. This can include explaining the length of the sentence and the type of work they are undertaking as part of the order. PBNI Victims Unit can also facilitate restorative interventions at the request of the victim and in appropriate circumstances.


