| What is the subject of this consultation? | | | |
| <p>This consultation concerns a proposed new risk-based approach to monitoring marine biotoxins in live bivalve molluscs. Sampling frequencies will no longer be set at regular intervals but will be influenced by variables such as location, past exceedance and toxin type.</p> <p>This proposed risk-based approach will aid compliance with requirements laid out in Regulation (EC) No 854/2004, to reduce risk of a toxin event going undetected, ensure biotoxin monitoring programmes are risk based and subsequently increase confidence and assurance in Northern Ireland's live bivalve mollusc industry.</p> | | | |

Background to the Consultation

Consuming shellfish contaminated with biotoxins can lead to illness, therefore there are legislative requirements laid down in EU Food Hygiene legislation that stipulates shellfish can only be commercially harvested from production areas that are classified and monitored for a range of parameters, including toxin producing phytoplankton and marine biotoxins to ensure the shellfish comply with the regulatory limits.

Section B, paragraphs 4 and 5 of Annex II of the Regulation (EC) No. 854/2004 states:

“The sampling frequency for toxin analysis in the molluscs is, as a general rule, to be weekly during the periods at which harvesting is allowed. This frequency may be reduced in specific areas, or for specific types of molluscs, if a risk assessment on toxins or phytoplankton occurrence suggests a very low risk of toxic episodes. It is to be increased where such an assessment suggests that weekly sampling would not be sufficient. The risk assessment is to be periodically reviewed in order to assess the risk of toxins occurring in the live bivalve molluscs from these areas.”

FSA in Northern Ireland currently implements monthly biotoxin monitoring, however we have now undertaken a risk-based assessment on biotoxins to determine appropriate sampling frequencies.

The risk assessment was completed in August 2018. This assessment used all available data between January 2011 and June 2018 for both biotoxin and phytoplankton across all 7 Loughs, including weekly data relating to Belfast Lough from June 2014 to June 2018.

Proposal

To implement the new risk-based approach to biotoxin monitoring from 1st October 2019, including a review phase after 6 months of implementation.

This will:

- aid compliance with Regulatory requirements
- reduce risk of a toxin event going undetected from 17.6% to 2%.
- ensure biotoxin monitoring programmes are risk based
- further underpin confidence and assurance in Northern Ireland’s live bivalve mollusc industry

Sampling schedules can still be forecast six months in advance and will be provided by the FSA as normal, however the sampling frequency for a particular production area (Lough) will vary depending on the month and toxin type.

Phytoplankton monitoring frequencies in NI will remain unchanged. The risk assessment highlighted that current data cannot reliably support that phytoplankton monitoring can be used to predict flesh toxin exceedance. Continual review of monitoring data will strengthen the current data set and allow for future review.

Consultation

The FSA in NI recognises that the implementation of current and future official control monitoring programmes is facilitated by our Delivery Partners. Therefore, we would like your views on the new risk-based approach to biotoxin monitoring, including potential impacts on your business or organisation.

An example of the proposed sampling schedule beginning Oct 2019 have been provided. We have also included a sample schedule relating to Oct 2018 – April 2019 to aid comparison. Please see Annex C - Comparison of sampling schedules.

This consultation will last for a six-week period, to provide interested parties in Northern Ireland with the opportunity to comment on the proposals.

A stakeholder meeting will also be arranged as an opportunity to discuss the proposed amendments to the FSA in NI's biotoxin monitoring programme. In addition to general views, the FSA in NI would appreciate feedback in relation to the questions below:

Q1: Do you agree with a risk-based approach to reduce risk of a toxin event going undetected?

Q2: What potential challenges may this approach present for you, your organisation or your business?

Q3: Do you agree the proposed approach will aid compliance with Regulation EC No. 854/2004 Annex II Section B, paragraphs 4 and 5?

Q4: Do you agree the proposed approach will further underpin confidence and assurance in Northern Ireland's live bivalve mollusc industry?

Responses

Disclosure of the information you provide
