1. Introduction

On 18th January 2021 the Northern Ireland Environment Agency (NIEA) published its public consultation paper on the extension of the existing NIEA Regulatory Charging Policy from 01st April 2021 to 31st March 2023.

The consultation period ran for 8 weeks from the 18th January 2021 to the 15th March 2021. This is available to view here; https://www.daera-ni.gov.uk/consultations/public-consultation-paper-extension-existing-niea-regulatory-charging-policy-1-april-2021-31-march

The current NIEA Regulatory Charging Policy expires on the 31st March 2021 consequently a new policy is required setting out charging arrangements for the next two years. It is also proposed that during this time period NIEA will undertake a strategic review of NIEA regulatory fees and charges.

1.1. Purpose of this document

The purpose of this document is to summarise the consultation comments received, provide our response to these comments and confirm the final decisions. This document also describes how we carried out the consultation and who responded.

1.2. Background

NIEA through its regulatory responsibilities protects and improves the environment and the natural resources of Northern Ireland which is critically important in supporting sustainable development and economic growth. NIEA is committed to delivering an effective and supportive regulatory system which is fair and proportionate to those we regulate, including the level of charges we apply.

This is achieved in a number of ways including providing advice and guidance to regulated operators and our stakeholders so they understand and comply with environmental regulations and standards.

The Regulatory Charging Policy covers those fees and charges associated with Waste, Water and Pollution Control Regulations, and are listed in Annex A.

The purpose of this consultation is to seek comments on the following;

- 1. The proposal to extend the current NIEA Regulatory Charging Policy 2016 2021 by a further two years until 31st March 2023. During this two year extension period the NIEA will undertake a strategic review of the current policy and develop a new policy in line with the legislative framework. This is in line with the Regulatory Transformation Programme (RTP).
- 2. The application of the 2020 2021 GDP deflator in 2021 2022 in order to maintain the 2020 2021 charges. This GDP deflator will apply in 2021 2022 of the new policy with the option for NIEA to review in the final year (2022 2023) should it be considered appropriate.

1.3. How we ran the consultation

NIEA launched this consultation on 18th January 2021 and it ran until 15th March 2021 (8 weeks). We published the consultation on the <u>DAERA consultation page</u> and facilitated consultation responses through the <u>NI Direct Citizen's Space</u> on-line platform.

Consultees were also able to respond directly to the RTP Team by email, telephone or by post. Given Covid-19 restrictions collation of any post to our main office was coordinated with business team staff.

Through e-mail correspondence we contacted relevant stakeholders in-line with NICS guidance, including but not limited to, The Executive Office, Department Ministers, Members of the Assembly, Northern Ireland MPs, Law Society for NI, Environment & Planning Law Association for NI and those organisations identified under Section 75 of the Northern Ireland Act 1998.

Through e-mail correspondence we contacted relevant stakeholders with an interest in the NIEA Regulatory Charging Policy including but not limited to, authorisation holders,

environmental consultants, and local councils. Notification of the consultation was also raised at the Government waste working group and other environmental agencies were also informed.

2. Summary of responses

In total we received 9 responses before the deadline, which comprised of 7 online responses through Citizens Space and 2 email responses directly to the RTP Team. These responses to each question of the consultation are summarised in Annex B.

Of these respondents there were several organisations that represent many hundreds of interested parties and regulated operators.

The list of organisations and groups that declared their participation in the consultation is provided in Annex C.

3. Issues raised

This section documents the main issues raised during consultation and our response to each.

Question 7:

Do you support the proposed measures for the extension of the current NIEA Regulatory Fees and Charges Policy for 2 years?

8 of the 9 responses (89%) answered 'Yes'. A number of comments were raised, please refer to table below alongside the response from NIEA.

Ulster Farmers Union (UFU) -

- 1. The UFU rejects the proposition that those who are subject to regulation in the public interest should pay for the scheme administration through charges and are opposed to the cost recovery policy. The UFU objects to the requirement to pay any fees under this charging policy.
- of fees and charges on companies and operators subject to a range of environmental regulations. NIEA regulatory fees and charges are designed to recover costs from regulated operators, based on the polluter pays principle and in accordance with government and treasury guidance.

1. NIEA discharges its regulatory functions through the application

- 2. Paragraph 2.3 in the consultation document outlines that 'income from regulatory fees and charges, to cover the costs associated with the regulation of environmental activities is a key revenue stream for NIEA.' It is concerning that NIEA see the income from charging as a key revenue stream as this puts less
- 2. NIEA deems income from regulatory fees and charges as a key revenue stream as it covers the costs (salaries and associated overheads) incurred in discharging its regulatory functions.

of a focus on delivering efficiencies within the Agency and more on further regulating to increase incomes.

3. The UFU is concerned that instead of constantly reviewing the whole inspection and administration process and identifying areas where costs could be reduced, DAERA will always take the easy option which is to increase the charges to farmers who are unable to pass on these additional costs to customers.

- 4. The UFU would highlight that Integrated Pollution Prevention and Control (IPPC) is a significant financial burden to those pig and poultry farms that fall under the regulations and as stated in correspondence over the years, the UFU feels that the charges for this regime are excessive. While we understand the fees in Northern Ireland are lower than those in the rest of the UK, we feel that it is totally unnecessary to increase these any further.
- 3. The planned strategic review by NIEA will consider the processes associated with regulatory fees and charges, so as to develop a policy and scheme that is financially sustainable and works better for business and the environment and in line with future legislative changes. NIEA would seek to include the UFU as a key stakeholder during the process of the strategic review of the regulatory fees and charges.
- 4. The charges associated with the regulation of scheduled activities, including industrial scale intensive agricultural activities, under the Pollution Prevention and Control (IE) Regulations (NI) 2013. There are approximately 244 permitted sites operating intensive pig and poultry units. Regulatory fees and charges for industrial scale intensive agricultural activities have increased annually from 2016 by the GDP Deflator and these remain lower than the rest of the UK.

- 5. The UFU would question the need for the current level of application and annual subsistence fees. Farm Quality Assurance scheme inspectors already inspect many pig and poultry farms and the charges to the farmer for these are as follow:
 - Red Tractor Poultry Scheme Annual Fee £127.15
 - Red Tractor Pig Scheme Annual Scheme £59.25 In comparison to the excessive current fees of £2315 £3977 for the standard farming installation IPPC application plus an annual fee of between £1198 £2494. While it is understandable that there are additional inspection requirements for NIEA officials when inspecting IPPC farms, it is unlikely that this would amount to the difference between what private sector organisations are charging for quality assurance inspections and the DAERA charges.
- 6. In recent years NIEA has developed a risk-based approach to IPPC farm inspections which is to be welcomed however, there have been no corresponding decrease in the fees that are charged yet DAERA outline that these fees are based on cost recovery.

5. The regulatory fees and charges reflect the complexity of permitting and regulation of industrial scale installations to ensure that environmental impacts are appropriately controlled and managed. Fees and charges associated with the regulation of PPC installations are in relation to environmental management. Farm Quality Assurance schemes are outside the scope of this public consultation and the planned strategic review.

6. Whilst the Department has developed a risk based approach to inspections under PPC this does not mean that the complexity of processing applications (permits / variations / transfers or surrenders) or the evaluation of reports and range of issues dealt with has changed. The charges reflect more than just the number of inspections. This consultation deals solely with the extension

of the existing charging schemes, including the PPC Charging Scheme as consulted on in 2012 with the introduction of the Industrial Emissions Directive. Please refer to the original charging scheme consultation at the following link;


