

Trade in Goods Data Analysis Northern Ireland – USA (2019-2021)

This pack draws on publically available information collected by HMRC in relation to the Regional Trade Statistics for imports and exports from/to the USA for Northern Ireland (NI). This slide pack includes information and analysis on:

Background to Source Data

• HMRC Regional Trade Statistics have been the basis of the analysis. Data are downloaded from the HMRC website:

UK Trade Info RTS Trade Data

- Data are presented for the calendar years 2019, 2020 and 2021.
- A proportion of the export data from the HMRC database could not be attributed to any UK region. The data appears as 'unallocated' within the tables.
- The data are only available for goods. Trade in services is not included in this analysis.
- The data from companies who are not registered for VAT are not included in RTS.
- Figures may not add due to rounding.
- The data may be subject to quarterly revisions.

Summary of Key Messages

UK Trade in Goods with USA – Imports

- Total NI imports in 2021 were £7.8bn. Imports from the USA were £524m which was 7% of total NI imports. USA is the 3rd largest country for NI imports.
- NI's imports from the USA decreased from £786m in 2019 to £569m in 2020 (-28%). Imports decreased further to £524m in 2021 (-8%).
- Across the UK, total imports from USA decreased from £41,775m in 2019 to £36,577m in 2021 (-12%). In 2021, the share of NI's imports from the USA was 6.7% compared to 7.4% for England, 11.1% for Scotland and 13.3% for Wales.

UK Trade in Goods with USA – Exports

- Total NI exports were £7.8bn in 2021. Exports to the USA were £909m, which was 12% of total NI exports. USA is the 2nd largest country for NI exports.
- NI's exports to the USA decreased from £1,165m in 2019 to £967m in 2020 (-17%). Exports decreased further to £909m in 2021 (-6%).
- Across all UK regions, total exports to USA decreased from £52,211m in 2019 to £43,481m in 2021 (-17%). In 2021, the share of NI's exports to the USA was 11.6% compared to 15.2% for England, 12.2% for Scotland and 14.4% for Wales.

USA Import Analysis by Sector (SITC1)

- Machinery & transport equipment, miscellaneous manufactured articles and chemicals accounted for 90% in NI Imports from USA in 2019, 89% in 2020 and 91% in 2021.
- Imports from the USA decreased in NI by 33%, Wales by 33%, England by 15% and Scotland by 5% from 2019-2021.
- From 2019-2021, the sector which had the largest increase in imports for NI (£20.0m) and Scotland (£342.9m) was chemicals. For England, mineral fuels, lubricants & related materials increased by £818.5m, while for Wales crude materials, inedible, except fuels increased by £46.7m over the period.

USA Export Analysis by Sector (SITC1)

- Machinery & transport, chemicals and miscellaneous manufactured articles accounted for 91% of NI exports in 2019, 90% in 2020 and 87% in 2021.
- From 2019-2021, exports to the USA decreased in NI by 22%, Wales by 20%, Scotland by 16% and England by 13%.
- Across the UK, sectors which had the largest increase in exports from 2019-2021 were chemicals in Scotland (£278.2m) and Wales (£22.3m), manufactured goods in England (£769.4m) and food & live animals in NI (£6.7m).

Summary of Key Messages

Import Analysis by Sector – SITC2

- The top 10 SITC2 sectors for NI provided 77% of total imports from USA in 2021, which was lower than Wales (83%), but higher than Scotland (70%) and England (64%).
- In 2021, 51% of NI imports from USA were provided by the top 5 SITC2 sectors Power generating machinery & equipment (17%), Chemical materials & products (11%), Electrical machinery, apparatus & appliances (9%), Plastics in primary forms (8%) and General industrial machinery & equipment (6%).
- Power generating machinery & equipment was the largest SITC2 commodity for NI accounting for 17% of exports in 2021. It was the 2nd largest commodity for England (10%), 1st for Scotland (16%) and 2nd for Wales (27%).
- Looking at the UK as a whole, the top 5 largest imports from the USA in 2021 were: Petroleum, petroleum products & related materials (£4.6bn), Power generating machinery & equipment (£3.8bn), Miscellaneous manufactured articles (£1.9bn), General industrial machinery & equipment (£1.9bn) and Electrical machinery, apparatus & appliances (£1.8bn).


Export Analysis by Sector – SITC2

- The top 10 SITC2 sectors for NI provided 88% of total exports to the USA in 2021, which was higher than Wales (81%), Scotland (76%) and England (72%).
- In 2021, 67% of NI exports to USA were provided by the top 5 SITC2 sectors Machinery specialised for particular industries (21%), Medicinal & pharmaceutical products (21%), Other transport equipment (9%), Professional, scientific & controlling instruments & apparatus (8%) and Furniture & parts thereof (8%).
- Machinery specialised for particular industries was the largest SITC2 sector for NI accounting for 21% of exports in 2021. It did not feature within
 the top 10 sectors for England, Scotland or Wales.
- Looking at the UK as a whole, the top 5 largest export sectors to the USA in 2021 were: Road vehicles (£5.7bn), Medicinal & pharmaceutical products (£4.1bn), Power generating machinery & equipment (£3.4bn), Miscellaneous manufactured articles (£3.1bn) and General industrial machinery & equipment & machine (£2.3bn).

UK Trade in Goods with USA - Imports

Imports from the USA were £524m in 2021 which was 7% of total NI Imports.





- Total NI imports in 2021 were £7.8bn. Imports from the USA were £524m which was 7% of total NI imports. USA is the 3rd largest country for NI imports.
- Ireland accounted for over a third (36%) of NI imports in 2021. This was followed by China (10%), USA (7%), Netherlands (6%) and Germany (6%). Collectively, the top 5 countries made up 66% of NI's imports (£5.1bn).

The share of total UK imports from the USA was 7.9% in 2021.



- Nl's imports from the USA decreased from £786m in 2019 to £569m in 2020 (-28%). Imports decreased further to £524m in 2021 (-8%). Overall, from 2019 to 2021 there was a 33% decrease in Nl's imports from the USA.
- The share of total NI imports from the USA decreased from 9.7% in 2019 to 6.7% in 2021.
- Across all UK regions, total imports from the USA decreased from £41,775m in 2019 to £36,577m in 2021 (-12%).
- In 2021, the share of Ni's imports from the USA was 6.7% compared to 7.4% for England, 11.1% for Scotland and 13.3% for Wales.
- NI had 1.4% of UK imports from USA in 2021, which was the lowest share amongst all UK regions. England accounted for 72.6% followed by Scotland at 7.6% and Wales at 5.9%. The remaining 12.5% was unallocated.

UK Trade in Goods with USA - Exports

Exports to the USA were £909m in 2021, which was 12% of total NI exports.





- Total NI exports were £7.8bn in 2021. Exports to the USA were £909m, which was 12% of total NI exports. USA is 2nd largest country for NI exports.
- Ireland accounted for 40% of NI's exports in 2021. This was followed by the USA (12%), Netherlands (4%), Canada (4%) and Germany (4%). Collectively the top five countries made up 64% of NI's exports (£5.0bn).

The share of total UK exports to the USA was 14% in 2021.

- Ni's exports to the USA decreased from £1,165m in 2019 to £967m in 2020 (-17%). Exports decreased further to £909m in 2021 (-6%). Overall, from 2019 to 2021 there was a 22% decrease in Ni's exports to the USA.
- The share of total NI exports to USA decreased from 12.8% in 2019 to 11.6% in 2021.
- Across all UK regions, total exports to USA decreased from £52,211m in 2019 to £43,481m in 2021 (-17%).
- In 2021 the share of Ni's exports to the USA was 11.6% compared to 15.2% for England, 12.2% for Scotland and 14.4% for Wales.
- NI had 2.1% of UK exports to the USA in 2021, which was the lowest share amongst all UK regions. England accounted for 79.4% followed by Scotland at 7.6% and Wales at 5.0%. The remaining 5.9% was unallocated.

Import Analysis by Sector (SITC1)

Machinery & transport equipment, miscellaneous manufactured articles and chemicals accounted for 90% in NI Imports from USA in 2019, 89% in 2020 and 91% in 2021.



- From 2019-2021, machinery & transport equipment, miscellaneous manufactured articles and chemicals accounted for the majority of Ni's imports from the USA.
- Imports of machinery & transport equipment accounted for approx. £1,092.0m (58%) of total imports from 2019-2021. This was followed by chemicals at £332.5m (17%) and miscellaneous manufactured articles at £273.3m (15%).
- Imports of chemicals increased by £20.0m from 2019-2021 (+18%). In contrast, machinery & transport equipment decreased by around £198.1m (-42%) and miscellaneous manufactured articles by £52.1m (-44%).

Machinery & transport equipment and chemicals were key import sectors across all regions in 2021.





- Key sectors across all regions in 2021 were machinery & transport equipment and chemicals. Miscellaneous manufactured articles was an important sector for England, NI and Scotland, while mineral fuels, lubricants & related materials was important for England, Scotland and Wales.
- The top importing sectors for NI were machinery & transport equipment (53%), chemicals (25%) and miscellaneous manufactured articles (13%). Collectively they accounted for 91% of total NI imports.

Import of goods from the USA decreased across all regions from 2019-21.

- Imports from the USA decreased in NI by 33%, Wales by 33%, England by 15% and Scotland by 5% from 2019-2021.
- From 2019-2021, the sector which had the largest increase in imports for NI (£20.0m) and Scotland (£342.9m) was chemicals. For England, mineral fuels, lubricants & related materials increased by £818.5m, while for Wales crude materials, inedible, except fuels increased by £46.7m over the period.
- Machinery & transport equipment had the largest decrease in imports in England (£4.3bn), NI (£198.1m), Scotland (£647.8m) and Wales (£547.2m) from 2019-2021.

Export Analysis by Sector (SITC1)

Machinery & transport, chemicals and miscellaneous manufactured articles accounted for 91% of NI exports in 2019, 90% in 2020 and 87% in 2021.



- Machinery and transport equipment, chemicals and miscellaneous manufactured articles accounted for the majority of NI exports to the USA from 2019-2021.
- From 2019-2021, exports of machinery & transport equipment accounted for approx. £1.3bn (42%) of total exports to the USA, followed by chemicals at £763.1m (25%) and miscellaneous manufactured articles at £691.1m (23%).
- Exports of miscellaneous manufactured articles decreased by £123.9m from 2019-2021 (44%) and chemicals by £98.5m (31%). In contrast, exports of food & live animals increased by £6.7m (56%).

Key export sectors across all regions in 2021 were machinery & transport, chemicals and miscellaneous manufactured articles.

Total UK Export of Goods to USA by SITC1 Sector in 2021



- Key sectors across all regions in 2021 were machinery & transport equipment, chemicals and miscellaneous manufactured articles. Collectively these sectors accounted for 83% of exports for England, 87% for NI, 57% for Scotland and 55% for Wales.
- Mineral fuels, lubricants & related materials was a key sector for Wales as it accounted for 36% of exports. Beverages & tobacco was an important sector for Scotland accounting for 24% of exports to the USA.

Export of goods to the USA decreased across all regions from 2019-2021.

- From 2019-2021, exports to the USA decreased in NI by 22%, Wales by 20%, Scotland by 16% and England by 13%.
- Across the UK, sectors which had the largest increase in exports from 2019-2021 were chemicals in Scotland (£278.2m) and Wales (£22.3m), manufactured goods in England (£769.4m) and food & live animals in NI (£6.7m).
- Machinery & transport sector had the largest decline in exports from 2019-2021 in England (£4.7bn), Wales (£401.2m) and Scotland (£322.0m). The largest decrease in NI was within the miscellaneous manufactured articles sector (£123.9m).

Import Analysis by Sector (SITC2)

Power generating machinery & equipment accounted for 13% of NI imports in 2019 and 17% in 2020 & 2021.

- The top 10 SITC2 sectors for NI provided 81% of total imports from USA in 2019, 80% in 2020 and 77% in 2021.
- Electric machinery, apparatus & appliances and Power generating machinery & equipment featured within the top 3 sectors from 2019-2021.
- Over the period 2019-2021 power generating machinery & equipment accounted for the largest value sector (£291.1m), followed by electrical machinery, apparatus & appliances (£240.3m) and furniture & parts thereof (£174.9m).

Power generating machinery & equipment featured within the top 2 SITC2 sector across all UK regions in 2021.

- The top 10 SITC2 sectors for NI provided 77% of total imports from USA in 2021, which was lower than Wales (83%), but higher than Scotland (70%) and England (64%).
- In 2021, 51% of NI imports from USA were provided by the top 5 SITC2 sectors Power generating machinery & equipment (17%), Chemical materials & products (11%), Electrical machinery, apparatus & appliances (9%), Plastics in primary forms (8%) and General industrial machinery & equipment (6%).
- Power generating machinery & equipment was the largest SITC2 commodity for NI accounting for 17% of exports in 2021. It was the 2nd largest commodity for England (10%), 1st for Scotland (16%) and 2nd for Wales (27%). Other commodities which featured within the top 10 sectors across all UK regions included: Electrical machinery, apparatus & appliances, General industrial machinery & equipment and Other transport equipment.
- Plastics in primary forms (8%), Furniture & parts thereof (6%) and Road Vehicles (6%) accounted for £104.7m of NI's imports from USA in 2021.
 These sectors did not feature within the top 10 sectors for England, Scotland and Wales.
- Petroleum, petroleum products & related materials featured within the top 10 sectors for England, Scotland and Wales, however it did not fall within NI's top 10 sectors.
- Looking at the UK as a whole, the top 5 largest imports from the USA in 2021 were: Petroleum, petroleum products & related materials (£4.6bn), Power generating machinery & equipment (£3.8bn), Miscellaneous manufactured articles (£1.9bn), General industrial machinery & equipment (£1.9bn) and Electrical machinery, apparatus & appliances (£1.8bn).

Medicinal & pharmaceutical products accounted for 25% of NI exports in 2019, 20% in 2020 and 21% in 2021.

- Over the period 2019-2021 Medicinal & pharmaceutical products was the largest value sector (£676.7m), followed by Machinery specialised for particular industries (£583.0m) and furniture & parts thereof (£434.2m).

- The top 10 SITC2 sectors for NI provided 88% of total exports to the USA in 2021, which was higher than Wales (81%), Scotland (76%) and England (72%).
- In 2021, 67% of NI exports to USA were provided by the top 5 SITC2 sectors Machinery specialised for particular industries (21%), Medicinal & pharmaceutical products (21%), Other transport equipment (9%), Professional, scientific & controlling instruments & apparatus (8%) and Furniture & parts thereof (8%).
- Machinery specialised for particular industries was the largest SITC2 sector for NI accounting for 21% of exports in 2021. It did not feature
 within the top 10 sectors for England, Scotland or Wales.
- Sectors which featured within the top 10 sectors across all UK regions included: Medicinal & pharmaceutical products, Other transport
 equipment, Professional, scientific & controlling instruments & apparatus, Electrical machinery, apparatus & appliances and Power generating
 machinery & equipment.
- Machinery specialised for particular industries (21%), Furniture & parts thereof (8%) and Telecomms & sound recording & reproducing apparatus & equipment (3%) accounted for £293.0m of NI's exports to USA in 2021. These sectors did not feature within the top 10 sectors for England, Scotland and Wales.
- Looking at the UK as a whole, the top 5 largest export sectors to the USA in 2021 were: Road vehicles (£5.7bn), Medicinal & pharmaceutical products (£4.1bn), Power generating machinery & equipment (£3.4bn), Miscellaneous manufactured articles (£3.1bn) and General industrial machinery & equipment & machine (£2.3bn).
