A free remote interpreting service for British Sign Language (BSL) and Irish Sign Language (ISL) users in Northern Ireland has been introduced to provide the Deaf community with access to NHS111 and all health and social care services during the pandemic, 24 hours a day, 7 days a week.

Virus testing expanded

Testing for the coronavirus has been expanded to include surveillance testing in GP surgeries and hospitals, as well as increased testing in care homes. It has also been extended to cover key workers in other sectors, as well as health and social care. More: <u>bit.ly/35tO29r</u>
