#### Context

Phase 7 Service Delivery saw the majority of services making good progress towards attaining the pre-pandemic level of delivery.

This report for December 2021 will focus on the following areas:

- Elective Care
- Cancer Services 14 Day and 62 day
- Psychological Therapies

#### **Elective Care**

HSCB has allocated £12.7m for elective care in 2021/22. While the Trust is continuing to deliver against the elective care plan, following a review of the WLI plan in December 2021, slippage of £1.1m was identified. The HSCB was informed of this projected slippage and has since confirmed to the Trust that this funding will not be retracted. The Trust is exploring alternative opportunities to ensure the full allocation is utilised.

In addition to additional waiting list initiative work, the Trust has also been undertaking validation of waiting lists to ensure they are accurate and that patients continue to require assessment. This is one of the areas of focus of the regional Waiting List Management Unit (WLMU), and funding has been provided to Trusts to undertake a further extensive validation exercise targeting longest waiting patients for IP/DC treatment and outpatient assessment across all elective specialties. This will be an administrative process supported by clinical input as required. The Trust is currently recruiting 3 additional staff to support this work and it is anticipated that validation work will commence in March 2022.

#### **Inpatients and Daycases**

During December 2021, the Trust delivered 89% (76%/IP & 93%DC) of the level of activity that was delivered during December 2019. During December 2021, the Trust over-delivered on predictions for both inpatients and day cases. There were 345 Inpatient treatments delivered against a predicted 145 and 1,563 Day Cases delivered against a predicted 1,490.

At the end of December 2021 the total inpatient & day case waiting list has grown to 23,886 patients, reflecting an 18% (3,610) increase from April 2020, and 55% of these patients are now waiting over 52 weeks.

During the month of December 2021, there were 30 cancellations of Day Case Admissions (Red Flag, Suspect or Confirmed Cancers) with 2 Red Flag Day Case admissions still to be re-booked.

#### **Outpatients**

During December 2021, the Trust delivered 91% (92% New & 91% Review) of the level of activity that was delivered during December 2019. The Trust delivered 4,668 new outpatients against a predicted 4,189 (112%) and 9,798 review outpatients were delivered against a predicted 9,622 (102%), with a greater level of face to face appointments being delivered against the plan.

At the end of December 2021 the Outpatients waiting list is 54,277, a slight reduction compared to November 2021 (55,216), and we have seen a 32% (13097 patients) increase in the numbers of patients waiting for outpatient assessment since April 2020. 51% of these patients are now waiting over 52 weeks.

#### **Endoscopy**

During December 2021, the Trust delivered 684 endoscopies against a predicted 570 and delivered 109% of the level of activity that was delivered during December 2019.

At the end of December 2021 the total endoscopy waiting list has grown to 5,142 patients, reflecting a 37% increase from April 2020. 53% of these patients are now waiting over 52 weeks compared to 6% at the end of April 2020, and access to endoscopy has been identified as an area of considerable concern to commissioners, and in Trust's risk register.

Following completion of a demand capacity analysis for the Endoscopy service the Trust has commenced discussion with the HSCB to explore recurrent and non-recurrent funding opportunities to address the identified capacity gap and waiting list backload. Discussions in January were positive and a follow-up meeting is planned for February 2022.



#### **Diagnostics**

During December 2021, the Trust delivered 7,194 diagnostic imaging tests for 5 modalities against a predicted 7,303 and are currently achieving 103% of the activity that was delivered during December 2019. This remains a high performing service, which reliably meets or exceeds its plans for each phase of Rebuild. The Trust delivered 609 Echo's against a predicted 500 and 103% of the activity that was delivered during December 2019, reflecting a recovering position for this service

#### **Cancer Care**

The number of red flag referrals received for all suspect cancer tumour sites during December 2021 was 18% greater than that in December 2019. The increase in red flag referrals is seen across many sub-specialties in particular Lower GI, Urology, Upper GI, Skin, Gynae, and Lung.

During December 2021, the patient activity delivered within the cancer pathways when compared to December 2019 was 141% for breast 14 day pathway, 78% for 31 day pathway and 90% for 62 day pathway.

#### **14-Day Breast Pathway**

During December 2021, of the 284 patients seen, 61% were seen within 14 days of referral and 111 patients waited over 14 days. This was mainly due to the previously flagged re-categorisation of low risk patients to urgent status by our clinical team. Access performance for 1-23 January 22 is much improved, with 96% of women referred seen within 14 days of referral and 7 patients waited >14 days.

There is however an underlying instability in the service, with workforce challenges due to recent resignations and retirements. This emerging risk has been escalated to HSCB.

It is noticeable that access to this services is experiencing challenges in 4 of the 5 Trusts, and a Regional Demand/Capacity exercise is being carried out by the Health and Social Care Board. The outcome will be presented at the end of January 2022, but the Western Trust has already concluded this work locally, and has submitted a phased proposal for investment to uplift capacity to the Commissioner.

#### 31 Day Pathway

During December 2021, of the 107 patients treated, 98% received their first definitive treatment within 31 days of a decision to treat and 2 waited over 31 days. All Trusts are continuing to perform well against this access standard.

#### **62 day Pathway**

During December 2021, of the 60.5 treated, 42% received their first definitive treatment within 62 days of referral and 35.0 (41 patients) waited over 62 days. The specialty with most breaches is Urology. The Commissioner has indicated that an investment case to uplift capacity should be prepared, and a proposal is being finalised by the Trust to provide Urology Theatre sessions at Omagh HCC to help address Urology waiting lists on a regional basis, the Trust has also recently appointed a new Consultant Urologist.

Workforce challenges continue to affect these services, with consultant vacancies in Radiology and Pathology a particular issue. Other relevant pressures are the increased demand for prostate MRIs due to the change in clinical guidance, and the short notice cancellations by patients due to positive COVID-19 cases and the requirement for patients to isolate.

In general, the 62 day pathway continues to be challenged by limited access to surgery across sites which is significantly impacting on delivery. This is due to the continued need to support ICU staffing from within theatres core staffing baseline.

The Trust is continuing to present priority patients to the Regional Prioritisation Group (RPOG) for consideration where additional capacity is being commissioned.



#### **Psychological Therapies**

At the end of December 2021, there were 1,300 people waiting over 13 weeks; and there have been small but steady decreases in the numbers of patients breaching the access target since September 2021. The total number waiting has also reduced steadily since May 2021.

New referrals in December 2021 reflects **61%** of December 2019 demand, which is supporting the improving position.

The Trust continues to deliver activity levels well above those achieved pre pandemic, and is achieving 151% (129% New and 153% Review) of the level of activity delivered during December 2019. This masks longstanding issues with hard to fill vacancies and general staff absence which prevailed in the pre-pandemic period.

Targeted work as part of the 'Working Together - Delivering Value' programme has been focussed on a range of improvement actions including the adoption of a checklist by referrers, streamlining of and enhanced triage of patients referred, and implementation of new systems, which all show positive progress. Working groups have been set up to take forward other tests of change in the new year around involving group work between Adult Psychologist Therapy Service & Primary Care Liaison Service. Overall, work is progressing well and staff are positively engaged in the process. The waiting list for Cognitive Behavioral Therapy (CBT) services is decreasing, however due to staffing issues at present the Psychology waiting list has increased slightly.

The Adult Mental Health (AMH) service workforce task and finish group involving the Clinical Director of Psychology and Assistant Director, Community AMH was established in December 2021 to review the service workforce and introduce a model which enables skill mix to support increased capacity for assessment and intervention.

#### **Unscheduled Care**

During December and early January, the Trust experienced considerable pressures on its unscheduled care services, requiring activation of the Full Capacity Protocol in December and in early January in both acute hospitals. Numbers of people presenting at ED remain higher than in 2020/21, but are broadly in line or lower than pre-pandemic levels.

The high numbers of patients breaching the 12 hour standard remains the most prominent feature of this service currently, with all Trusts seeing over 1,000 patients per month breaching this standard.

#### COVID-19

The most recent surge saw the number of COVID-19 positive inpatients in our hospitals peak at 96 patients on the 3<sup>rd</sup> January 2022. This has fallen to 58 patients on 26<sup>th</sup> January 2022.

There are also higher numbers of COVID-19 positive inpatients in our community hospitals in this surge, which is understandable given the high level of transmission with the Omicron variant.


Outbreaks in residential and Nursing Homes also peaked in early January, with 41 homes in Outbreak. This has now fallen to 28 Independent Sector homes in outbreak (as at 26<sup>th</sup> January 2022)

















# **Complex Discharges % within 48 Hours**










