#### **OPTIONS CONSULTATION**

There was significant interest in, and an excellent response to the Energy Strategy Options Consultation. We are pleased that despite continuing Covid-related restrictions, we were able to connect with a wide range of people and received even more responses than the 161 submitted to the Call for Evidence.

During the 12-week consultation period, there were:


- 7,839 views of the consultation page
- Over 5,600 views of the Energy Strategy Animation video
- 3,870 downloads of the Policy Options Consultation paper
- 1,109 downloads of the Consumer friendly paper

#### **Promotion and engagement**

To spread the word and encourage as wide a range of responses as possible, the Options Consultation was supported through multiple communications activities. This included a Social Media campaign, events, presentations, information videos and an animation. Outside of our own 'Have Your Say' events we met with around 30 groups including Councils, business associations, the energy and renewable industry, consumer groups, housing representatives and youth groups, to answer questions and discuss the content of the strategy.

There was widespread promotion of the consultation from other organisations, including local councils, government departments, business, voluntary and social economy groups, and the energy industry. All of the activities aimed to encourage people to visit the consultation section of the Departmental website and submit a response. #### **'HAVE YOUR SAY' EVENTS**

The consultation period was extremely busy for the Energy Strategy team as they talked to people through a wide variety of events and presentations. Over 250 participants attended five Energy Strategy 'Have Your Say' events. The sessions were held online and were based on each of the five Options Consultation Themes:



Each session included presentations on the relevant theme and, most importantly, the opportunity for you to 'have your say' through interactive breakout rooms. The breakout sessions allowed participants to provide direct feedback on the emerging Energy Strategy. These discussions were hugely valuable to the consultation process and will feed into the options consultation review.

#### **Consultation Responses**

- · 282 formal responses received
- There was a good mix of rural (27%), urban (31%) and semi-urban (23%) respondents (remaining 19% provided no answer)
- There were responses from throughout Northern Ireland, with most originating from County Antrim (approximately 33%)
- Approximately 30% responded as Domestic Energy Consumers
- Approximately 20% responded as Business Energy Consumers
- A full consultation report will be published alongside the Energy Strategy later this year.

#### **NEXT STEPS**

Feedback to the consultation includes a number of responses that highlight the urgency of clear direction from government on decarbonisation.

We remain committed to publishing an Energy Strategy this year. However, given the breadth of issues covered, some of the underpinning policies require further research, evidence building and consultation. We therefore also intend to publish an Action Plan outlining the programme of work for the development of detailed policy on key topics, alongside an Energy Evidence Programme and detailed Statistical Methodology report.

#### **Stakeholder engagement**

We are extremely grateful to those who have not only responded to the consultation but actively engaged in working groups, the Expert Panel and other stakeholder groups to support this work so far. As we finalise the strategy we will assess how to best continue to engage with all stakeholders to ensure an effective transition from development to implementation.
