This statistical fact sheet presents a range of analysis regarding enrolments in the Northern Ireland Further Education Sector covering academic years 2015/16 to 2019/20.

Further Education Sector Activity in Northern Ireland by Local Government District: 2015/16 to 2019/20

The analysis covers all enrolments, regulated enrolments, Higher Education enrolments as well as qualifications and performance (retention, achievement and success rates) in the FE Sector by Local Government District.

The figures in this statistical fact sheet are based on a full year count of enrolments; however, it should be noted that students may be enrolled on more than one course at a given time and may, therefore, be counted as two or more enrolments. This is the third edition of this fact sheet and it is released annually. As we want to engage with users of our statistics, we invite you to feedback your comments on this publication.

Unknown*: Postcodes with unassigned LGDs are mainly accounted for by Republic of Ireland (RoI) domiciled student enrolments (72.4%, 2,249).

- In 2019/20, Armagh City, Banbridge and Craigavon LGD had the highest proportion of the 132,354 enrolments, accounting for 13.4% (17,764), and Mid and East Antrim the lowest, with 5.5% (7,341).
- In all eleven LGDs, over half of student enrolments were at one particular college. However, this ranged from Causeway Coast and Glens, where 52.3% of student enrolments were at Northern Regional College, to Fermanagh and Omagh, where 95.9% of student enrolments were at South West College.
- Around a third of enrolments from students residing in either Antrim and Newtownabbey LGD or Lisburn and Castlereagh LGD were at Belfast Metropolitan College (33.5% and 30.7% respectively).
- Notably, in North West Regional College, a relatively large number of enrolments did not have an associated postcode (1,903), accounted for mainly by Republic of Ireland (RoI) domiciled students (84.6%, 1,609).

Figure 1: Proportion of all enrolments in the FE Sector by Local Government District in 2019/20



- FE College enrolments have decreased by a net 14.0%, from 153,817 in 2015/16 to 132,354 in 2019/20; this includes a 10.6% fall on 2018/19 (148,002), linked partly to COVID-19. Medium-term factors include fewer part-time enrolments, improved school exam performance and a 'demographic dip' in 16-19-year-olds.
- Since 2015/16, enrolments have decreased in net terms in each of the 11 Local Government Districts.
- The largest net percentage decrease has been in Antrim and Newtownabbey (17.9%), from 9,524 in 2015/16 to 7,819 in 2019/20, while the smallest has been in Derry City and Strabane (6.4%), from 13,528 to 12,659.




Figure 2: All enrolments in the FE Sector by Local Government District (2015/16 to 2019/20)

- Regulated enrolments at FE Colleges decreased by a net 16.6% between 2015/16 (129,274) and 2019/20 (107,760).
- Since 2015/16, regulated enrolments have decreased in net terms in each of the 11 Local Government Districts.
- The largest net percentage decrease has been in Fermanagh and Omagh (23.7%), from 9,376 in 2015/16 to 7,150 in 2019/20.
- The smallest net percentage decrease has been in Armagh City, Banbridge and Craigavon (11.8%), from 16,494 in 2015/16 to 14,550 in 2019/20.




Figure 3: Regulated enrolments in the FE Sector by Local Government District (2015/16 to 2019/20)

- Higher Education enrolments at FE Colleges decreased by a net 11.2% between 2015/16 (11,631) and 2019/20 (10,323).
- Since 2015/16, Higher Education enrolments have decreased in net terms in each of the eleven LGDs.
- The largest net percentage decrease has been in Derry City and Strabane (29.3%), from 1,190 in 2015/16 to 841 in 2019/20.
- The smallest net percentage decrease has been in Ards and North Down (0.3%), from 779 in 2015/16 to 777 in 2019/20.




Figure 4: Higher Education enrolments in the FE Sector by Local Government District (2015/16 to 2019/20)

- In 2019/20, Armagh City, Banbridge and Craigavon had the highest proportion of the 65,659 qualifications achieved, accounting for 14.1% (9,268), and Mid and East Antrim the lowest, with 5.5% (3,628).
- In ten of the eleven LGDs, over half of student qualifications achieved were at one particular college, with the largest concentration being in Fermanagh and Omagh where 95.0% of qualifications were at South West College. However, in Antrim and Newtownabbey LGD, 48.4% of qualifications were at Northern Regional College.
- Many qualifications achieved by students residing in either Antrim and Newtownabbey LGD or Lisburn and Castlereagh LGD were undertaken at Belfast Metropolitan College (40.7% and 31.9% respectively).
- Notably, in North West Regional College, a relatively large number of qualifications awarded did not have an associated postcode (953), accounted for mainly by those gained by Rol domiciled students (86.0%, 820).

Figure 5: Proportion of qualifications achieved in the FE Sector by Local Government District in 2019/20



- The number of qualifications achieved at FE Colleges decreased by 25.5% between 2015/16 (88,153) and 2019/20 (65,659).
- Since 2015/16, the number of qualifications awarded has decreased in net terms in all eleven Local Government Districts.
- The largest net percentage decrease has been in Fermanagh and Omagh (35.3%), from 6,217 in 2015/16 to 4,022 in 2019/20.
- The smallest net percentage decrease has been in Ards and North Down (20.4%), from 8,765 in 2015/16 to 6,980 in 2019/20.




Figure 6: Number of qualifications achieved in the FE Sector by Local Government District (2015/16 to 2019/20)

Unknown*: Postcodes with unassigned LGDs are mainly accounted for by Republic of Ireland (RoI) domiciled students [final year enrolments (75.8%), final year completers (75.8%) and qualifications achieved (75.4%)].

- The retention rate for the FE Sector was 91.4% in 2019/20, while those across the eleven LGDs ranged from 90.1% in Derry City and Strabane to 92.5% in Lisburn and Castlereagh.
- While the success rate for the FE Sector was 78.6% in 2019/20, the success rates across the eleven LGDs ranged from 74.5% in both Mid Ulster and Antrim and Newtownabbey to 83.9% in Ards and North Down.
- In 2019/20, while retention rates were relatively similar across the eleven LGDs (a range of over 2.3 percentage points), the success rate range was 9.4 percentage points.




Figure 7: Performance rates of final year regulated enrolments in the FE Sector by Local Government District in 2019/20

- In 2019/20, almost a fifth (18.4%) of the NI population (aged 16 and over) lived in the Belfast LGD, whereas Belfast residents made up 12.0% (15,918) of the 132,354 enrolments in the NI FE Sector.
- In contrast, while 9.4% of the NI population (aged 16 and over) lived in Newry, Mourne and Down, people living in this LGD accounted for 11.8% (15,646) of the 132,354 enrolments in the NI FE Sector.
- When considering the LGD proportions of the NI population against the LGD proportions of NI FE Sector enrolments, it should be noted there are no unknown postcodes for population, but there are 2.3% unknown postcodes with regards to FE Sector enrolments. Of the 3,108 enrolments with unknown postcodes in the FE Sector, 2,249 were Rol domiciled student enrolments, accounting for 1.7% of enrolments within the sector.




Figure 8: All enrolments in the FE Sector and NI Population aged 16+ by Local Government District in 2019/20

Notes

- 1. Figures are correct as at 13th November 2020.
- 2. The Local Government District is based on the postcode provided by the student at the time of enrolment.
- 3. The level of study indicates the nationally recognised qualification level of the course.
- 4. 'Regulated enrolments' consist of Higher Education courses ('Level 4 or above') and courses at 'Level 3 or below' that appear on either the Register of Regulated Qualifications (RRQ) or DfE's Prescribed List of Approved Qualifications (PLAQ).
- 5. Geographical data have been sourced from the Central Postcode Directory to assign Local Government Districts to each enrolment. Approximately 3% of all enrolments are not assigned to a Local Government District due to invalid georeferencing or non-Northern Ireland domiciled students.
- 6. Performance analysis is based on Final Year Enrolments and excludes transfers.
- 7. Withdrawals are included where there is an achieved outcome.
- 8. Enrolments of students in their final year of a course who have completed the course and subsequently achieve are regarded as final year achievements.
- 9. Retention rate is defined as the percentage of final year regulated enrolments completed by students.
- 10. Achievement rate relates to the percentage of final year regulated enrolments completed by students who achieve a qualification.
- 11. Success rate (or overall measure of performance) is the percentage of final year regulated enrolments of students who complete and achieve a qualification.
- 12. Achievement and success rates are based on final year full and partial achievements.
- 13. Tables for lower geographies, for example, Assembly Area, District Electoral Area and Ward are available from <u>NISRA's Neighbourhood Information Service (NINIS)</u> and <u>Open Data NI</u>.
