




Annual Report of the Needle & Syringe Exchange Scheme For the period 1st April 2015 to 31st March 2016

This report summarises data that is collected on the operation of the Northern Ireland Needle and Syringe Exchange Scheme (NSES). It relates to the twelve-month period between 1st April 2015 and 31st March 2016. The anonymised data is collected by the 14 pharmacies and 1 Trust-based service that participate in the Northern Ireland Needle and Syringe Exchange Scheme (NSES) which was introduced in April 2001.

Participating Pharmacies

Between 1st April 2015 and 31st March 2016 the Public Health Agency funded the Scheme through 14 pharmacies based across Northern Ireland and 1 Community Addiction Team Service based in Railway St. Ballymena. A further 6 pharmacies are due to start participating in the scheme by the end of 2016. The current services can be seen in the map (Figure 1).




Number of Visits to the Pharmacies

A total of 28,978 visits to facilitate the exchange of needles and syringes were made to the service over the twelve month period between 1st April 2015 and 31st March 2016. This is an increase in demand of 2,265 (8%) visits on the 2014/15 figure (26,713). Table 1 and Figure 2 below show the number of visits by each Health and Social Care Trust area. The Belfast Trust area had the highest number of visits (52%) and the Southern Trust area the lowest

number of visits (3%). In addition, Belfast Trust experienced a substantial increase (up 16%) in demand while the Southern Trust noted a drop of 8% compared to the previous year.

Number of Visits made by Health & Social Care Trust Area of Residents

Data collected by the pharmacies includes the first 4 digits of the client's postcode e.g. BT12 and this allows a restricted amount of analysis on the Trust area of residence of each client. Table 2 shows the highest percentage of visits made was from residents of Belfast Trust area (43%) and the lowest was from the Southern Trust area (4%). A small number of postcodes (1%) were not submitted to the database and 5 visits were made by non-residents of Northern Ireland.

The number of visits made per 100,000 HSCT population can be seen in Table 3 ranging from the highest, Belfast Trust area (3,543 visits per 100,000 population) to the lowest, Southern Trust area (284 visits per 100,000 population). The percentage change in visits from 2014/15 to 2015/16 is most significant in the Belfast Trust area with a 14% rise in visits by Belfast Trust area residents to Needle & Syringe Exchange Scheme pharmacists.



Number of Packs Issued by Health & Social Care Trust Area of Pharmacy

Table 4 and Figure 3 show the number and percentage of packs issued within each area. Pharmacies in the Belfast Trust area issued the highest number of packs (45%) and the lowest number was issued by pharmacies in the Southern Trust area (3%).



Number and Percentage of Packs Issued to Outreach Workers

During 2015-16, the Public Health Agency funded outreach services in all 5 Trust areas. These services work with people who use substances (drugs or alcohol) harmfully, but who are not ready to enter into treatment, providing interventions to reduce harms to their clients. In three of the Trust areas (Belfast Trust area, Northern Trust area and the Southern Trust area), the services have significant caseloads of injecting drug users, and therefore provide outreach needle exchange to those clients.

The outreach workers visit pharmacies to obtain packs on behalf of clients. Figure 4 shows the number and percentage of packs issued to outreach workers in the period 1st April 2015 to 31st March 2016. Of the total packs issued to outreach workers, the highest number, 493 (54.4%), was issued to staff working in the Northern Trust area, while 293 (32.3%) was issued to staff working in the Belfast Trust area and 120(13.2%) was issued to staff working in the Southern Trust area.



Age of Clients using the Needle & Syringe Exchange Scheme


Table 5 and Figure 5 show the numbers and percentages by age band. Please note the figures are shown by Trust of residence of the client.

During 2015-16, the highest percentage of visits to the scheme was from clients aged 31 years and over (58%) which was an increase of 6% on the previous year. The 26-30 year old category accounted for 24% of visits, an increase of 1 percentage point on 2014/15 (23%). In contrast, among those aged 18-25 years, visits decreased from 25% last year to 16% this year, a difference of 9 percentage points .There was no change in the Under 18s.




Gender of Clients using the Needle & Syringe Exchange Scheme

Table 6 and Figure 6 illustrate the number and percentage of visits from males and females using NSES by their Health & Social Care Trust of Residency. Visits were mostly from male clients (85%). The highest percentage of visits from females using the service (18%) was in the Belfast Trust.

Number of Visits by main drug of injection

Table 7 illustrates the various types of drug users who used the Scheme. Figure 7 charts the trend since 2013/14.


Under the Scheme, data on the main drug clients report injection ("user type") is collected on those injecting Amphetamines, Opiates, Steroids, Opiate & Steroid, Steroid & Tanning, Tanning and User Type Not Known. Participating pharmacies collected 80% of data on injecting detail which is an increase of 2 percentage points) on last year (78%). Of the total visits to the Scheme it was recorded that 32.76% of users injected steroids rising to 33.23% when steroid & tanning are included in this figure.

Over the last 3 years, the recording of user type has increased from 68% of visits in 2013/14 to 78% in 2014/15 and 80% in 2015/16. The Public Health Agency is continuing to encourage and support pharmacists to collect this data.

Number and Percentage of Return of Cin Bins

Tables 8 and Figure 8 show the number and percentage of bins returned to pharmacies.


A cin bin (incinerator bin) is a sealed container which is used to safely dispose of used needles and syringes and the aim is for clients to return their used bins to the pharmacy for secure disposal. Each pack contains a bin. Clients may request extra bins and these are accounted for in the figures. During 2015/16 data shows that 40% of bins issued to users were returned, showing that the return rate has decreased by 5 percentage points since 2014/15. Pharmacies in the South Eastern Trust area continue to have the highest number of bins returned (68%), closely followed by the Western Trust (65%); both areas have lower rates of opiate users and more steroid users. The lowest return rate of 25% was by pharmacies in the Belfast Trust area, a decrease of 6 percentage points since 2014/15.

The Public Health Agency and Health and Social Care Board have been actively working with participating pharmacies to increase return rates. In addition to this, the PHA have been actively working with Belfast City Council and disposal units have been established in public places in Belfast to reduce the occurrence of discarded needles. A 24 hour contact line has also been set up by the Council for the collection of any discarded needles.

In 2016, the Public Health Agency worked with community pharmacies to carry out a survey with Needle Exchange clients to identify where and how unreturned injecting equipment is disposed of, and how clients can be supported to return their used equipment. The results of this survey will be used to inform future interventions.

Cross Boundary Flow

Table 9 illustrates the cross-boundary flow of clients accessing the Scheme. In comparing the Health & Social Care Trust of residence of the client and the Trust area of the pharmacy that they visit it is noteworthy that 52.8% of visits from the South-Eastern Trust are to visit a pharmacy in the Belfast Trust. Of the visits from clients who are residents of the Southern Trust 14.8% are visits to Belfast Trust pharmacies and 10.6% are visits to Northern Trust pharmacies. In the Western Trust 95% of visits are to a Western Trust Pharmacy. Table 10 shows the percentage change in visits by Trust residents to pharmacies between 2014/15 and 2015/16.
