




Higher Education Statistical Fact Sheet 8: Total NI Domiciled HE Enrolments: 2017/18 to 2021/22

Northern Ireland domiciled students enrolled on Higher Education courses in the UK and Republic of Ireland – 2017/18 to 2021/22

The chart and table below provide information on NI domiciled students enrolled on Higher Education (HE) courses in the UK and Republic of Ireland (Rol). This includes HE enrolments at UK Higher Education Institutions (HEIs) and Further Education (FE) colleges, as well as Rol institutions.

- Between 2017/18 and 2021/22, the total number of NI domiciled students enrolled on HE courses at UK HEIs, UK FE colleges and RoI institutions increased by a net 1,935 (3%), from 75,820 to 77,755.
- Between 2020/21 and 2021/22, the total number of NI domiciled students enrolled on HE courses at UK and ROI institutions increased from 77,465 to 77,755 (a net increase of less than 1%).

Notes:

1. From 2021/22 onwards, Republic of Ireland data are rounded prior to being added to our total. This is due to the Higher Education Authority (HEA) adopting a new statistical disclosure policy in Q4 2022.

2. A change was made to the data coverage in this fact sheet in 2020/21, as Alternative Provider (AP) data from the HESA Student Alternative record was combined for the first time with the usual HESA Student Record data submitted by HEI providers. An AP is any provider of higher education courses: not in direct receipt of recurrent funding from UK funding bodies; not a Further Education college; and not registered as 'approved (fee cap)' on the Office for Students (OfS) register. Historical figures in the online open data tables have been produced back to, and including, 2017/18, using this new methodology.

3. For the years 2018/19, 2019/20 and 2020/21, some Northern Ireland (NI) domiciled other undergraduate students on a Higher Education (HE) course at an English Further Education College (FEC) had an unknown mode of study. These students have been included in the totals above but not in the mode of study breakdown.

4. Data on NI domiciled enrolments at Trinity College Dublin (TCD) were unavailable for the 2018/19 edition of this report, TCD figures were approximated using 2017/18 data and added to the Republic of Ireland (Rol) Institutions' total. Data including TCD are now available for 2018/19, figures have been updated for this publication.

5. The definition of a Higher Education student used by the different data sources may vary slightly due to different data coding and variable definitions.

6. Prior to 2019/20 NI Higher Education Institutions (HEIs) and FECs both included Foundation Degree students within their respective populations, meaning the two populations overlapped. Foundation Degree students are now excluded from the HEI population. Older data in this fact sheet have been revised to exclude Foundation Degree students from the HEI population, so will differ from previous iterations of this fact sheet.

7. To prevent the identification of individuals, HE figures have been rounded to the nearest 5, in line with HESA rounding strategy, with 0, 1 and 2 rounded to 0.

8. For consistency, the same rounding strategy has been used on all figures in the table above.

9. Due to rounding, the sum of rows or columns may not match the totals shown.

10. Percentages are based on unrounded figures and rounded to the nearest integer.

11.
