

About Neighbourhood Renewal

The Neighbourhood Renewal Programme aims to reduce the social and economic inequalities which characterise the most deprived areas. It does so by making a long term commitment to communities to work in partnership with them to identify and prioritise needs and coordinate interventions designed to address the underlying causes of poverty. Neighbourhood Renewal Partnerships were established to be representative of local community interests together with appropriate Government Departments, public sector agencies, private sector interest and local elected representatives.


About Crumlin Ardoyne Neighbourhood Partnership

To take forward the Neighbourhood Renewal Programme, Crumlin/Ardoyne Neighbourhood Renewal Partnership was established in 2006 to oversee the development and delivery of the local Neighbourhood Renewal Action Plan. The Partnership currently has 16 members which include representatives from the local communities, voluntary and statutory organisations. The Neighbourhood Renewal Partnership meets on a monthly basis and its secretariat services are currently provided through the North Belfast Partnership.

The Partnership has established 4 working groups (see diagram below) to assist them in the identification, development and where appropriate the delivery of projects which aim to address the Strategy's 4 strategic objectives of community renewal, social renewal, economic renewal and physical renewal. They also assist local community organisations to co-ordinate actions that are beneficial for all communities living in the Crumlin/Ardoyne Neighbourhood Renewal Area (NRA).

It should be noted that the Crumlin Ardoyne Partnership and Working Groups (sub-groups) have all signed up to and abide by the Neighbourhood Renewal Code of Practice and Guiding Principles and subsequent Sub-group Terms of Reference.

Crumlin Ardoyne Neighbourhood Renewal Partnership Management Committee

The Management Committee of Crumlin Ardoyne Neighbourhood Partnership provides the overall direction to the work of the partnership.

With the development of the first neighbourhood action plan in 2007 all those groups involved in delivering neighbourhood renewal had a seat at the management committee. After the review of the implementation plan in 2009 it was agreed that they move towards a smaller more focused committee. This coincided with the re-launch of 4 working groups which would draw their membership from all those groups working on neighbourhood renewal.

The Management Committee meets at 10.00am on the first Wednesday of each month.

1. Chairs Working Group

A Chairs Working Group exists as a Management Team to ensure that working groups are focused on the action plans. While the management committee meets to provide overall direction and to take reports on progress from each working group, the Chairs Working Group is focused on the operational side of the work. The current agenda, for example, is focused on tracking neighbourhood renewal outcomes, supporting the working groups by identifying external resources, ensuring effective communications and encouraging collaborative working between working groups.

Formally the Chairs Working Group is made up primarily of the 4 Working Group Chairs, the chair of the partnership, one Belfast Regeneration Directorate official, the Crumlin/Ardoyne Neighbourhood Renewal Coordinator and one North Belfast Partnership Official. However, all Working Group vice-chairs are also invited to participate to ensure co-ordination and continuity.

2. Working Groups

There are four Working Groups. The role of each Working Group is to focus on a specific number of outcomes and actions. Membership of Working Groups is open to anyone working or living in the Neighbourhood Renewal Area who feels they have a contribution to make to support neighbourhood renewal and the work of the Neighbourhood Partnership.

5. North Belfast Neighbourhood Partnership Chairs Forum

Crumlin Ardoyne Neighbourhood Partnership is one of five (5) neighbourhood partnerships in North Belfast. The other four are:

- Inner North Neighbourhood Renewal Partnership
- Rathcoole Neighbourhood Partnership
- · Ligoniel Neighbourhood Partnership
- Ballysillan and Upper Ardoyne Neighbourhood Partnership

The five North Belfast Neighbourhood Partnership Chairs meet bi-monthly to co-ordinate the work of neighbourhood renewal across North Belfast's most disadvantaged communities. The Chairs Forum, which is facilitated by BRD and the CANP Neighbourhood Renewal Coordinator, is a valuable mechanism for promoting the work of community organizations with responsibility for delivering Neighbourhood Renewal. The Forum also acts as a conduit for collective responses from Neighbourhood Renewal Partnerships to consultations, policy issues and potential collaborative funding opportunities.

Crumlin/Ardoyne Neighbourhood Renewal Partnership Projects

The Neighbourhood Renewal Investment Fund is currently supporting 14 organisations delivering services in the Crumlin/Ardoyne Neighbourhood Renewal Area. The projects deliver against the Neighbourhood Renewal objectives which are:

- > Community Renewal Community Relations & Advice
- Social Renewal Education, Youth, Health, & Crime
- Economic Renewal Worklessness (employability)
- > Physical Renewal Environmental & Improvements

The following projects are supported through the Neighbourhood Renewal Investment Fund:-

Cliftonville Community Regeneration Forum (CCRF), Manor Street Cliftonville Community Group, North Belfast Senior Citizens Forum

Cliftonville Community Regeneration Forum is the lead partner in a collaborative project – *Working Across the Generations* - with Manor Street Cliftonville Community Group and the North Belfast Senior Citizens Forum. CCRF aim to address the following themes in the Neighbourhood Action Plan: Economic, Employability and Education, Youth, Health and Community Life.

This collaborative project aims to deliver programmes that will develop the capacity of local people and offer training opportunities to provide them with community development skills. A wide range of programmes are offered including careers advice, skills training and employment, advice services, social enterprise and business start-up, childcare places, parenting programmes, accredited and non-accredited training, healthy lifestyle and suicide prevention, crime prevention and youth inclusion / diversionary projects. Additionally the project will work with other statutory agencies to address the issues of dereliction and improve the environment through the implementation of environmental improvement schemes.

Grace Women's Development Ltd and Ardoyne Association.

Grace Women's Development Ltd is the lead partner in a collaborative project – *Community Development & Relations* - with Ardoyne Association and aims to address the following themes in the Neighbourhood Action Plan: Economic, Employability and Education, Youth, Health and Community Life.

The main aims and objectives of this collaborative project are to deliver a range of community development services to meet the needs

of people living in the Crumlin / Ardoyne NRA. Services are developed in response to demand and include educational and training opportunities, provision of health and fitness programmes, personal development and health issues with young people deemed 'at risk' of becoming involved in anti-social behaviour during the summer months. Crèche facilities are available to reduce barriers to uptake in education, training and skills programmes.

The Vine Centre and Lower Oldpark Community Association

The Vine Centre is the lead partner in a collaborative project – *Crumlin Ward Initiative* - with Lower Oldpark Community Association and aims to address the following themes in the Neighbourhood Action Plan: Economic, Employability and Education, Youth, Health and Community Life.

The aims and objectives of this project are to deliver a range of community development services across the Crumlin / Ardoyne NRA. A wide range of services including advice services, childcare provision, community safety initiatives, education, training and employment support, evening diversionary programmes, health awareness, homework clubs, senior citizens clubs and safety and crime prevention targeting all age groups and sectors.

Ardoyne Youth Providers Forum, Marrowbone Community Association and Westland Community Group

Ardoyne Youth Providers Forum is the lead partner is a collaborative project – *Youth & Community Development Partnership* - with Marrowbone Community Association and Westland Community Group. The project aims to address the following themes in the Neighbourhood Action Plan: Youth, Health, Community Life, Education and Employability

The aims of this project are to deliver programmes and interventions across the Ardoyne, Marrowbone and Westland areas designed to complement the Neighbourhood Renewal priorities as set out in the Neighbourhood Action Plan. The main focus of this project is the delivery of youth services in these areas, however it also combines some community development initiatives and interventions to enhance and create social, community, economic and physical renewal. These include advice services, a local newsletter, pensioner and residents groups, afterschool clubs, youth clubs, transport services, volunteering and other evolving initiatives.

Community Restorative Justice (North Belfast)

This project works directly with the local communities to address issues of conflict through mediation. It will also work collaboratively with and through the NIO, DoJ, PSNI, BCC, YJA, PBNI, NIHE, local Neighbourhood Partnerships and community and voluntary organisations on developing responsive community safety initiatives. This project addresses the following themes in the Neighbourhood Action Plan: Social Environment/Community Safety.

Wishing Well Family Centre

This project provides services through the provision of childcare facilities in the Crumlin / Ardoyne area and neighbouring NRAs. Additional services within community development are delivered to address training, education, employment, volunteering and advice directly linked to the childcare focus. Placements from a number of secondary schools are offered which allow pupils to obtain a recognised NVQ childcare qualification. Additional training is delivered in first aid and child protection.

Cancer Lifeline

The purpose of this project is to reduce health inequalities in North Belfast through the delivery of a range of information and support services for those affected by cancer which are not available through mainstream health providers. The services provided include, community led cancer awareness prevention programmes, support and information services that include counselling, complementary therapies, library services, welfare benefits advice, support group sessions and 24 hour telephone support. Cancer Lifeline works with individuals from a range of community backgrounds to support people through their cancer journey.

New Life Counselling

This purpose of this project is to offer high quality counselling services to meet the needs of children, young people, adults and families. Referrals to the organisation are received from those affected by stress, anxiety, depression, relationship breakdown, and drug/ alcohol issues, bullying, self-harm and suicidal ideation. One to one counselling is offered at their premises at 25 Ardoyne Road and Unit 20 North City Business centre however, in addition, counselling services are offered at 12 outreach centres across the city and in 187 post primary schools across Northern Ireland.

Jigsaw Community Counselling

This purpose of this project is to offer high quality counselling services to meet the needs of children, young people, adults and families. Referrals to the organisation are received from those affected by stress, anxiety, depression, relationship breakdown, and drug/ alcohol issues, bullying, self-harm and suicidal ideation. The project

The Crumlin Ardoyne Neighbourhood Renewal Partnership continues to progress its Action Plan for the Neighbourhood Renewal Area through its 4 Working Groups.

Examples of work the Crumlin Ardoyne Working Groups are currently involved in include:-

The **Economic, Employability and Education Working Group** (known as the EEE Working Group) have continued to run 'One Stop Shop' in the area over the past financial year bringing together a range of training providers on a monthly basis in Crumlin and Ardoyne area. These included Prince's Trust, Ashton Centre, North Belfast Partnership, North City Business Centre, Bryson Future Skills, and Department of Employment & Learning. This was successful and will be continued in the next financial year however the group is looking at a variety of ways to promote the initiative to ensure the target audience is reached.

The EEE Working Group is continuing their work on mapping potential development sites for physical regeneration within the Crumlin Ardoyne Neighbourhood Renewal Area. The Girdwood site is now opened and members from this group have been sitting on the Girdwood Community Forum as part of the committee. Girdwood Hub is a place where you can access a number of services and modern facilities in a shared, safe and vibrant environment. It's available for community, leisure or educational activities and initiatives. There are classrooms in the hub for Belfast Metropolitan College to run their education and training programmes. These programmes are currently delivered from a range of venues across north Belfast.

The **Health & Wellbeing Working Group** continues to campaign and support The North Belfast QUIT Campaign which was developed to deliver one of the key priorities in its Action Plan to 'promote Healthy Lifestyle Choices'. This campaign was launched in 2014 and the group is trying to get all of North Belfast to commit to this charter. The need for a smoking cessation plan was based on statistical evidence from the BHSCT which showed the extremely high incidence of those presenting with COPD and cancer in North Belfast. Smoking was identified as one of the main factors that influenced these statistics, therefore the group pulled together a plan which included the QUIT campaign and charter. This year the group successfully gained the support of the PHA and BSCHT who signed up to champion this campaign.

The **Youth Working Group works** with young people from the NRA to address issues that are specific to young people, particularly those living in interface areas. The Working Group seeks to explore and develop the potential for a large shared first class youth facility accessible to all North Belfast Communities. The Youth Working Group continues to develop work with young people from across the six CANP neighbourhood renewal areas to enable them to participate in community planning and regeneration issues. The Youth Working Group continues with their project 'Time for Change' which is a cross-community project that has provided local communities and young people with real hope for the future. The group continues to support and train local young people in the area and develop the trust


and a relationship to encourage new friendships and develop new initiatives for the project. Future activities for the group include workshops on the difference between faiths, youth governance training, production of a DVD covering their collaborations, a North Belfast youth conferences for their peers, community research projects and much more.

The **Community Life Working Group** has been working to improve community safety in the NRA. They have worked to increase community participation and engagement between community, voluntary/statutory and private sectors in NRA. The Community Life Working Group completed a Community Safety Event this year to promote relationships with local youth, residents and PSNI in the Crumlin/ Ardoyne area. This was a facilitated workshop in Crumlin Road Gaol on 22nd March 2016.

Last year the group decided that they wanted to provide training for organisations to become a 'Safe Place' in relation to Domestic Violence. This year the group extended this and supported more organisations to become 'Bronze' trained and then these groups progressed to become 'Silver' trained. To date over 15 organisations in this area are trained as a result of the work of the Community Life Working Group. The group is developing this initiative and are looking to extend this training to all groups in North Belfast and to take some organisations to the next phase of this training so that North Belfast becomes 'a safe place for all'.


